System-Wide Carpet America Recovery Effort

CARE's differential assessment plan, which CalRecycle has conditionally approved, will take effect on April 1, 2022. The differential assessment is based on two factors: material type -- broadloom vs. tile -- and the percent of post-consumer (PC) content in new carpet. The Plan has four levels of assessment:

- Broadloom, <10% PC content: \$.35 per square yard
- Broadloom, > or = 10% PC content: \$.33 per square yard
- Carpet Tile, <10% PC content: \$.50 per square yard
- Carpet Tile, > or =10% PC content: \$.48 per square yard

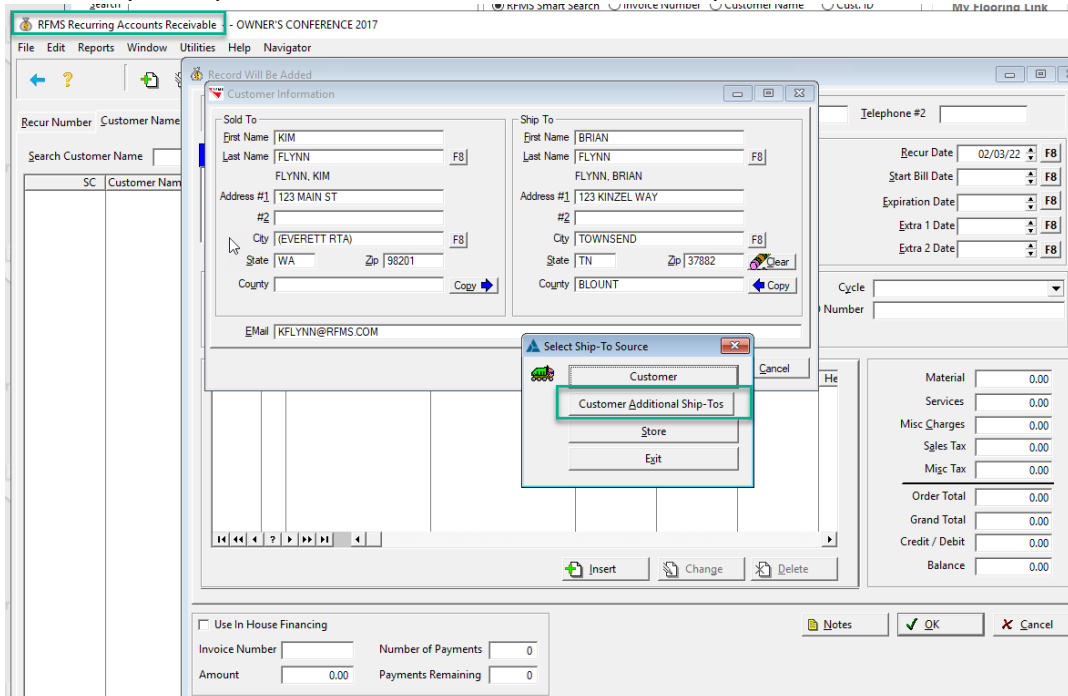

API

Version 1 of the RFMS API is approaching end of life. **After March 31st, 2022 RFMS will no longer provide support to the version 1 API.** Please know if you come across an issue or problem, we will not be able to provide any assistance.

The good news is **RFMS has developed version 2 of the API.** This new version was developed to provide high reliability, better performance, and tighter security.

Please take the appropriate steps to complete development efforts to move from v1 to v2 as soon as possible. If you have a software vendor that requires the RFMS API, please contact them to verify that their software currently supports v2 or that they will support it by the end of March 2022.
